Shawna Herwick, Administrative Director, Accreditation, Institutional Assessment, and Planning, presented information related to the remaining policies in sections C, D and E, due for review. She thanked the Board for commitment to the review project and handed out crosswalk documents for each section. She indicated that during the next review cycle, College handbooks will be reviewed to determine what can be moved from handbooks to policy and procedure.

Brett Bright, Vice-President for Student Success, Beatrice Campus Executive Director, gave an overview of the planning for men’s and women’s athletic teams including; wrestling, trapshooting, track, golf, rodeo, volleyball, tennis, and esports. Planning includes; campus locations, gym usage, use of off campus locations, equipment, housing and recruiting athletes, scholarships, part-time coaches, and mascot development. The Board requested an information sheet be developed listing all athletics and their campus locations.

Noting Dr. Carolee Ritter’s attendance at this meeting, Mr. Uhrmacher congratulated Dr. Ritter on being selected as the recipient of the 2022 Nebraska Community College Association (NCCA) Administrator’s Award.

ADMINISTRATIVE PRESENTATION/BOARD REVIEW

NPPD Check Presentation: Gary Thompson (Goal 8.4)

Nebraska Public Power District (NPPD) representative, Gary Thompson, presented \$5,000 scholarship award checks to each of the three campuses from the proceeds of the annual Nebraska Open golf tournament for community college scholarships. Mr. Thompson indicated he will be ending his thirty years of service on the NPPD Board in December.

NCCA Dues (Goal 9.4)

Dr. Illich presented the invoice for NCCA dues for 2023, received in the amount of \$69,942.37. Dues for 2022 were \$64,006.33.

2023-2024 Tuition and Fees (Goals 8.3, 8.5)

Amy Jorgens, Vice President of Administrative Services, presented potential tuition and fee rates for 2023-2024, showing a \$2.00 increase in tuition per credit hour and \$1.00 increase in fees. She indicated there is in importance in the tuition and fees timeline to allow for Financial Aid to package what the cost will be. Board members discussed proposed amounts and funding sources.

2023-2024 Room and Board Rates (Goal 7.6)

Ms. Jorgens distributed a document outlining potential room and board rates for 2023-2024. She presented a summary of residence hall facilities and related financing, budget assumptions, and proposed room and board charges.

New Credentials and Programs: Bev Cummins (Goals 1.3, 4.4, 4.7)

Bev Cummins, Vice President Program Development, Lincoln Campus Director, provided an overview of new credentials and programs that will be presented to the Board in December for consideration for submission to the Coordinating Commission.

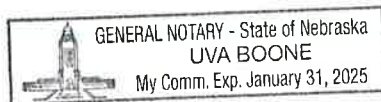
