This month's Accreditation Review will focus on how SCC is working collaboratively toward our common goal of a successful comprehensive evaluation process (or as we call it: "Mission -Accreditation"). SCC's approach to the comprehensive evaluation is driven by the pillars of Goal 9.6: input, reflection, transparency, compassion, positivity, and respect. Strategic goal 9.6 drives how we work together, communicate, and prepare for the comprehensive evaluation in April 2023.

Criterion Corner

In preparation for the comprehensive evaluation in April 2023, SCC is implementing several strategies to ensure a successful reaccreditation, including the monthly Accreditation Review newsletter and Passport challenges for each of us to learn more about accreditation at SCC (and win some fun prizes).

SCC also has an Accreditation Steering Team that began meeting monthly in April 2020. HLC's Criteria for Accreditation (Criteria 2 & 5) calls for institutions to ensure collaborative processes for shared governance, and the Accreditation Steering Team is just one of many examples of broad-based participation at SCC!

The Steering Team has approximately 20 faculty, staff, and administrators that work diligently to oversee the entire comprehensive evaluation process. The Steering Team is organized in smaller groups: Criterion Committees, Federal Compliance, and Communication/Engagement Planning. For employees who worked at SCC prior to 2012, you may recall that SCC had large accreditation workgroups with more than 100 employees working on the report and site visit. For the 2023 comprehensive evaluation SCC pivoted to involve employees in a broader, more dynamic approach. This change allows every SCC employee to be directly involved, rather than limit the primary involvement to committee members.

This month the Accreditation Steering Team's Criterion Committees are reviewing evidence used in the 2017 mid-cycle Assurance Review to determine which sources of evidence still apply to the 2023 comprehensive evaluation. Next, the Criterion Committees will identify what types of evidence are needed from each area of the College: Instruction; Student Affairs; Human Resources; Administrative Services; Technology; President's Office; Access, Equity, and Diversity; Program Development; Campus Operations; and more! In the coming months the Steering Team will begin meeting with each area to begin an ongoing dialogue on how each area of the College contributes to SCC's successful reaccreditation in April 2023.
