- Enrollment is up for the semester up 600 students or 6%. There are 9700 students. Milford enrollment is up 160 students, or 25%; Beatrice enrollment is up about 70 students.
- A second dorm on the Milford campus is being researched and legal counsel is working on an addendum. Legal counsel will work with Sampson Construction to establish a construction schedule, fee, etc.
- The inner part of Education Square has been secured so that an ID card is needed to enter into that area.

FACULTY ASSOCIATION REPORT

Bob Redler reported that both students and staff are glad to be back on campus. Enrollment has increased, and faculty are hoping it stays that way as it's been a major concern for faculty

Development of the program was from industry demand. Curriculum has been developed from meetings with local business owners' needs. There were 12 advisors who helped to build the curriculum. Instruction also includes information to prepare students to take the journeyman's test.

Some of the students are able to get part-time jobs in the afternoon while attending school.

After completion of the program, they must be an apprentice for four years. The program will count as one of those years. To go to a job site, an apprentice needs a journeyman with them.

The current students are from Iowa, Columbus, Seward, and Lincoln. The job market is good, with students starting at \$15-\$17/hour.

Stat. §§13-518 through 13-522, for the fiscal year beginning July 1, 2019, and ending June 30, 2020, equal to last year's total of budgeted restricted funds of \$89,850,581.36, plus the statutory 2.5% increase equal to \$2,246,264.54, plus allowable growth of \$0, plus an additional 1% increase of \$898,505.81 approved by at least 75% of the Governing Board resulting in total restricted funds authority of \$92,995,351.71 and the carryforward to future budget years of unused restricted funds authority in the amount of \$16,854,723.17. Such unused restricted funds authority may be used in later years as the Board of Governors deems appropriate to increase total restricted funds allowed by law.

2019-2020 PROPERTY TAX REQUEST AND 2019 PROPERTY TAX LEVY RESOLUTION

WHEREAS, Nebraska Revised Statute 77-1601.02 provides that the Board of Governors of Southeast Community College Area passes by a majority vote a resolution or ordinance setting the tax request; and

WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request;

NOW, THEREFORE, the Board of Governors of Southeast Community College Area, resolves that:

- 1) The total 2019-2020 property tax request is \$57,211,505.55 that includes the following separate funds:
 - a) General Fund: The 2019-2020 property tax request for the General Fund is \$44,999,871.50.
 - b) Capital Improvement Fund: The 2019-2020 property tax request for the Capital Improvement Fund is \$12,211,634.05.
- 2) The total assessed value of property differs from last year's total assessed value by 2.77% that includes the following separate levy valuations:
 - a) General Fund: The total assessed value of property for the general fund levy differs from last year's total assessed value by 2.77%.
 - b) Capital Improvement Fund: The total assessed value of property for the capital improvement fund levy differs from last year's total assessed value by 2.77%.
- 3) The total tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property would be \$.088257 per \$100 of assessed value that includes the following separate levies:
 - a) General Fund: The general fund levy tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property, would be \$.068796 per \$100 of assessed value.
 - b) Capital Improvement Fund: The capital improvement fund levy tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property, would be \$.019461 per \$100 of assessed value.
- 4) The Southeast Community College Area proposes to adopt a property tax request that will cause its tax rate to be \$.0937 per \$100 of assessed value.
 - a) General Fund Levy: The Southeast Community College Area proposes to adopt a General Fund property tax request that will cause its tax rate to be \$.0737 per \$100 of assessed value
 - b) Capital Improvement Fund Levy: The Southeast Community College Area proposes to adopt a Capital Improvement Fund Levy property tax request that will cause its tax rate to be \$.0200 per \$100 of assessed value.
- 5) Based on the proposed property tax request and changes in other revenue, the total operating budget of Southeast Community College Area will exceed last year's by 16.13%.
