This 18-hour course is intended for beginning riders 16 years and older and is designed to teach safe motorcycle operation.

The online eCourse is to be successfully completed one week prior to the start of the Friday evening classroom session. Approximately three weeks before the start date of the course, an email and letter will be sent with instructions on how to access the eCourse.

**Prerequisite:** Student must be at least 16 and able to balance and ride a bicycle. Students age 16 and 17 must have waiver signed by parent or guardian. Failure to provide will disqualify participation in class and a refund will not be available. A valid license required.

**Students must provide their own:**

- Dept. of Transportation approved helmet and eye protection
- Over-the-ankle footwear
- Long-sleeve shirt or jacket
- Long non-flare denim pants or equivalent
- Full-fingered gloves, preferably leather

**SCC will provide the motorcycles.**

All members of SCC's instructional staff are MSF Certified and approved by the state of Nebraska.

# Register Online for SCC Continuing Education Classes

You must have an email account to register online.

1. Go to <http://bit.ly/RegisterCE>.
2. **Search for your class** by entering either a **key word** in the title or the **course number**. Click **Submit**. (Enter information in only one field for broader results.)  
Key Word Example: *Driver*  
Course Number Example: *TRAN-3398*
3. **Select the course** for which you wish to register. Click **Submit**.
4. Enter your **personal information, certify your identification** and click **Submit**.  
\* You must provide your Social Security Number.
5. *Optional*: Enter your **Additional Registration Information** and click **Submit**.
6. If you want to register for additional classes, select **Search for more classes** under "Choose one of the following." If you are finished selecting the class(es) for which you want to register, select **Register now (check out)**. Select your **Payment Type**. Click **Submit**.
7. Enter your **payment information**. Click **Submit**.

You will see your **class acknowledgement** with information about your **SCC Student ID Number, SCC User ID** and **password**. **Print** this page for your records.

In the future it will be easy to register by logging in using your SCC User ID and password and it will not be necessary to provide your Social Security number again.
