New students completing an application for acceptance in a declared Program of Study at Southeast Community College may be eligible to apply for Federal Financial Aid, including federal grants, work-study and loans. This checklist outlines eligibility requirements and the awarding process.

- Check the priority filing deadline dates. Each starting term has a file by date to ensure adequate time for processing aid.
- Complete an Application for Admission to a specific Program of Study at SCC and provide all necessary admission requirements for full acceptance.
- Create a Federal Student Aid ID (FSA ID) at <https://studentaid.gov/fsa-id/create-account>. Once the FSA ID is accepted, you and your parent (if applicable), will complete the Free Application for Federal Student Aid (FAFSA) at <https://studentaid.gov>

For the **2023-2024** award year, the FAFSA is available beginning **October 1, 2022**. For FAFSA or FSA ID issues, contact the Federal Student Aid Support Center at **800-433-3243**.

- Review your Student Aid Report for accuracy upon receipt. Make any necessary corrections. SCC will receive an electronic summary of your FAFSA information and will begin processing your aid.
- Students selected for federal verification will be sent an **email** requesting additional information. Please complete the necessary paperwork and submit it to the Financial Aid Office within **15 days** of receiving the notice.*
- Upon receipt of the SCC Financial Aid Offer Notification email, you should **review** the aid offer on SCC's Self-Service site <https://selfservice.southeast.edu/student/FinancialAid/Home>  
- Complete New Student Enrollment as required for the registration process.

Questions regarding **special circumstances** should be directed to the Financial Aid Office.

If students will be receiving enough aid to cover all tuition/fees, room/board and books, they may be allowed to charge books to their student account. Students must have completed the financial aid and admissions processes prior to the start of the term. **If the process is not complete, the student will need to pay for books out of pocket.**

If financial aid is determined/awarded, then tuition, fees, housing (if applicable), and book charges do not need to be paid prior to the start of the term. Processed Financial Aid funds are applied directly to the student's business account upon receipt. Any remaining credit will be refunded by the Business Office directly to the student via U.S. Postal Service mail or direct deposit.
