

Chairperson Neal Stenberg called the special meeting, budget hearing, of the Southeast Community College Board of Governors to order at 3:02 p.m. on Tuesday, September 27, 2022, at the Milford Campus, 600 State Street, Milford, Nebraska.

Chairperson Stenberg welcomed everyone to the meeting. He indicated that it was necessary for any member of the public wishing to testify to sign in and that individuals would be allowed a maximum of five minutes to speak.

PUBLIC MEETING LAW COMPLIANCE STATEMENT

Chairperson Stenberg stated the public meeting notice had been published in the Lincoln Journal Star on Sunday, September 18, 2022, as well as posted on the bulletin board in the Area Office and on the website. He stated that the meeting is conducted according to the principles of the revised *Robert's Rules of Order*.

Chairperson Stenberg indicated that supplementary materials were available for the public, along with a copy of the Open Meetings Law.

2022-2023 BUDGET HEARING

Chairperson Stenberg convened the 2022-2023 public budget hearing at 3:05 p.m. Amy Jorgens, Vice President of Administrative Services, presented the 2022-2023 budget.

Ms. Jorgens reviewed the 2022-2023 budget information: general fund budget history (increased 3.60%, and there were salary and benefit increases of 3.8%); state aid summary (SCC will receive \$29,230,416 in state aid), valuations (total valuations were

\$68,938,388,188, an increase of 4.43% over last year), levy will remain unchanged from last year (9.37 cents/\$100 – 7.37 cents general and 2 cents capital), FTE & REU summary (audited FTE for 2021-2022 is 5,710.03), tuition rates (\$117/credit hour for tuition and fees, an increase of 2.63%), new initiatives (expanded budget of \$511,475), expanded restricted budget (to be evaluated on a case-by-case basis), general fund budget (assumptions: property valuation of \$68,938,388,188, or a 4.43% increase; for a general fund budget of \$97,805,036, potential capital improvement projects total \$264,735,000), capital improvement fund (available funds in 2022-2023 of \$16,900,000), total budget (\$348,168,302), and a review of budget documents to be filed.

Chairperson Stenberg closed the budget hearing at 3:20 p.m.

PUBLIC COMMENT ON 2022-2023 BUDGET

Chairperson Stenberg asked for public comment. There was no public comment.

BUDGET RESOLUTION 2022-2023

Discuss, consider and take all necessary action in regard to the proposed budget for Southeast Community College Area for the 2022-2023 fiscal year, pursuant to the provisions of Neb. Rev. Stat. §§13-501 to 13-513.

Dr. Weissinger moved to adopt the 2022-2023 budget resolution as follows and to authorize Chairperson Stenberg to sign the resolution. Seconded by Dr. Sherwood.

Chairperson Stenberg asked for discussion. There was none.

SOUTHEAST COMMUNITY COLLEGE AREA BOARD OF GOVERNORS 2022-2023 BUDGET RESOLUTION

BE IT RESOLVED that the Board of Governors of Southeast Community College Area does hereby adopt the proposed Budget Statement for the fiscal year beginning July 1, 2022 and ending June 30, 2023 in the amount of \$348,168,302 of budgeted expenditures prepared on the State of Nebraska 2022-2023 Basic Budget Form and does hereby authorize and direct the Secretary of the Southeast Community College Area Board of Governors to certify a copy of said adopted Budget Statement, attach thereto a copy of the proof of publication of the notice of hearing, and file the same with the Boards of Equalization and County Clerks of Cass, Fillmore, Gage, Jefferson, Johnson, Lancaster, Nemaha, Otoe, Pawnee, Richardson, Saline, Saunders, Seward, Thayer and York Counties, on or before September 30, 2022, and with the Auditor of Public Accounts of the State of Nebraska, all as provided by law.

BE IT FURTHER RESOLVED that the Board of Governors of Southeast Community College Area does hereby approve the amount of budgeted restricted funds as defined by Neb. Rev. Stat. §§13-518 through 13-522, for the fiscal year beginning July 1, 2022, and ending June 30, 2023, equal to last year's total of budgeted restricted funds of \$99,618,945.64 plus the statutory 2.5% increase equal to \$2,490,473.64, plus allowable growth of \$0, plus an additional

1% increase of \$996,189.46 approved by at least 75% of the Governing Board resulting in total restricted funds authority of \$103,105,608.74 and the carryforward to future budget years of unused restricted funds authority in the amount of \$28,142,021.74. Such unused restricted funds authority may be used in later years as the Board of Governors deems appropriate to increase total restricted funds allowed by law.
