Chairperson Boellstorff welcomed everyone to the meeting.

Chairperson Boellstorff stated that Mr. Uhrmacher and Mr. Hammons had excused absences.

PUBLIC MEETING LAW COMPLIANCE STATEMENT

Chairperson Boellstorff stated the public meeting notice had been published in the Lincoln Journal Star on Tuesday, September 14, 2021, as well as posted on the bulletin board in the Area Office and on the website.

TOPICS FOR DISCUSSION:

UPDATE FROM HLC LIAISON ON SCC'S ACTION PLAN TO ADDRESS ITS ASSURANCE REVIEW FINDINGS AND OVERVIEW OF HLC AND ROLE OF ACCREDITATION

Dr. Illich introduced Higher Learning Commission Liaison, Dr. Tom Bordenkircher.

Dr. Bordenkircher gave an overview of HLC and the role of accreditation in higher education, reviewed the types of accreditation, the mission and purpose of the Higher Learning Commission (HLC), 2020 regulatory changes, regional accreditors shift to institutional accreditation, substantive change, new criteria for accreditation, and the two current pathways for accreditation.

Dr. Bordenkircher reviewed SCC's past accreditation history, which, he indicated, had always included monitoring and focus visits.

Dr. Bordenkircher reviewed the 2017 Assurance Review Findings:

- Continue to refine use of data at all levels
- Expanded strategic plan progress reports to program and department levels
- Formalize co-curricular assessment plan
- Developed formal process for reviewing and updating policies and procedures
- Consolidate planning, budgeting and assessment processes through a specialized software solution
- Continue to show progress on major initiatives validated in the Assurance Review Team Report
- Continue to show progress on refinement of the assessment and use of student learning outcome data to improve learning
- Provide update on progress made toward multiple near-term facility projects during next accreditation visit in five years

Dr. Bordenkircher also reviewed points of the HLC Action Agreement identifying areas needed to make substantial progress before comprehensive evaluation in 2023:

- Facilities Master Plan
- Program length
- Strategic Planning (strengthened alignment of continuous improvement processes)
- Assessment of student learning
- Co-curricular assessment
- Policies and procedures

He noted the arrangement of an annual visit to assess progress, including a Board presentation.

Additionally, Dr. Illich, Scott Keene of Piper Sandler, and Colleen Duncan of Gilmore Bell, presented information on past and future financing, the revenue bond timeline for this project, and the bond resolution. Bond resolution would be reviewed and sent to Board of Governors after work session. Bond resolution will be presented to board for approval at October meeting.
