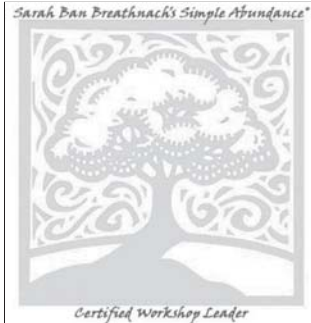


# Simple Abundance Close to Home
