Intermediate to advanced instruction in Gas Metal Arc Welding (GMAW) theory, safety, applications, manipulative skills, welding principles and procedures. Filler wire, shielding gases, welding power sources, welding of aluminum and welding processes on different joint configurations are included.

Students will have to supply their own safety glasses, leather gloves, arc welding helmet and pliers.
