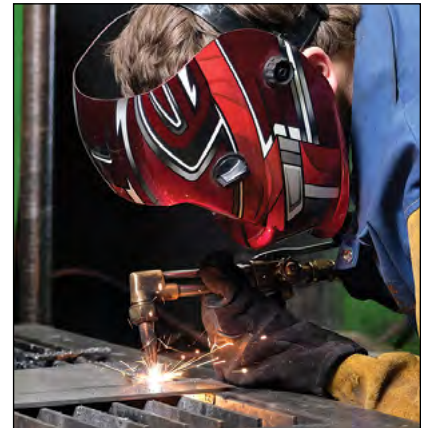


Gas Metal Arc Welding I (Steel)

Refunds for classes cancelled by the College are automatically processed and students are not required to submit a drop or withdrawal form for any classes cancelled by the College. Students can register for an electronic refund option online using Web Advisor or refund checks are mailed to the student's currently listed address.
