This class is intermediate to advanced instruction in Gas Metal Arc Welding theory, safety, applications, manipulative skills, welding principles, and procedures. Filler wire, shielding gases, welding power sources, welding of aluminum, and welding processes on different joint configurations are included.

Students must supply their own safety glasses, leather gloves, arc welding helmet, and pliers.
