Included in this course are classroom, nursing lab and clinical experiences in a health care setting.

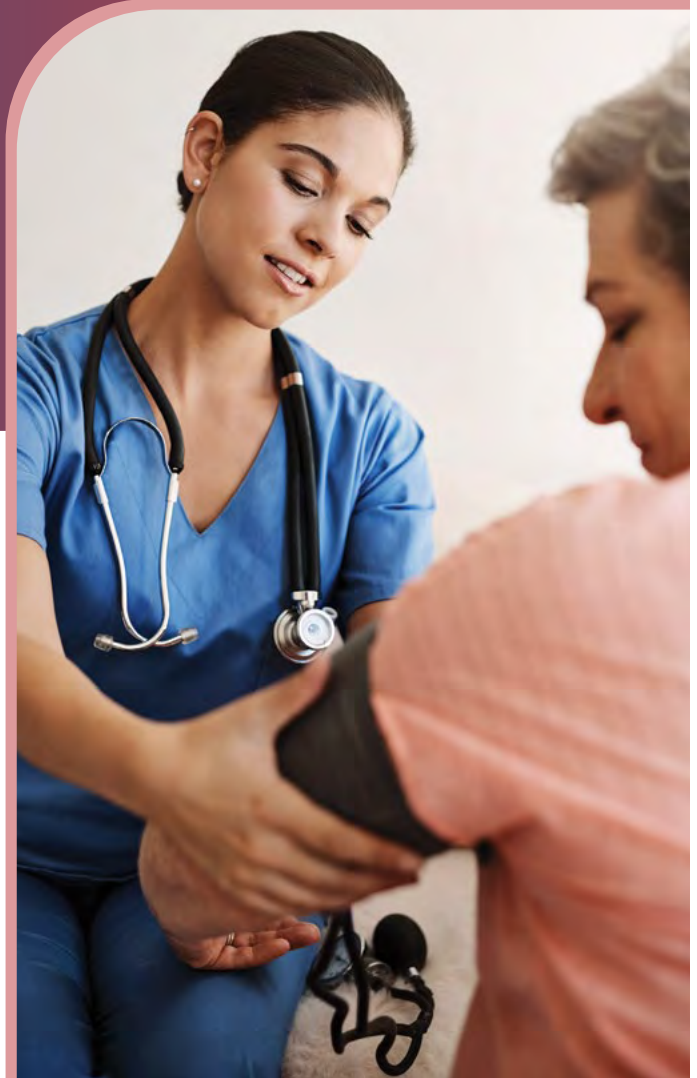
