

# Southeast Community College Specialized Program Accreditations

**Southeast Community College has been accredited by the Higher Learning Commission** (the largest institutional accreditor out of 19 recognized accrediting organizations) **since 1983**.

Accreditation provides assurance to the public, in particular to prospective students, that a college or university has been found to meet clearly stated requirements, criteria, and standards and that there are reasonable grounds for believing that it will continue to meet them. The institutional accreditors are highly trained, external, and private, nongovernmental/nonprofit organizations created for the specific purpose of reviewing higher education institutions and programs for quality.

Accreditation is valuable because it ensures programs of study fulfill the basic role of providing students with a quality education. It also assures employers that Southeast Community College has quality programs of study. In order for students to be eligible for federal financial aid and veterans' benefits, they must be enrolled in an accredited program recognized by the U.S. Department of Education. Accreditation also makes Southeast Community College eligible for federal grand funding.
