Criterion Corner

One of SCC's requirements to maintain accreditation is to have its offsite locations evaluated by HLC. Every five years HLC randomly selects a two or three Learning Centers or other locations for a modified site visit. The purpose of these multi-locations visits are to confirm SCC's continuing effective oversight of its locations and ensure that SCC maintains consistency in policy, procedures, and continuity of operations at its locations.

This term, SCC's York Learning Center and IBEW Training Center were selected for review. Just this week SCC received the great news from HLC that the locations met all of HLC's expectations and the report was accepted with no additional information needed. The site visitor shared suggestions on instructional oversight, academic and student support services, facilities, and marketing and recruitment information for continued improvement of the additional locations. Thank you to all who were involved in preparing the report and involved in the visit!
